T3 Retrievers is coming into a contractual agreement with said owner(s). T3 Retrievers (Tiffany N. Hegglund - Owner) and Buyer(s) agree to fulfill the entire content of this contract.

OUR CONTRACT:

T3 Retrievers Agrees:

- Our FIRST priority is the dog's well-being. To ensure ALL canines are treated properly: mentally, physically, and as healthy as possible.*
- Guarantee live puppies of a litter of two or more.*
 - o If a puppy is born alive, but does not survive, this still counts as a puppy in the litter.*
- If the dam does not become pregnant or has less than two puppies, then the owner will have a choice to breed again with no additional cost.*
- Or the owner(s) will have the choice to be refunded 75% of STUD fee (the remaining 25 % will go towards boarding costs and services).*
- The total amount of stud fee is \$_____*

T3 agrees to collect half of the payment at the time of drop off. T3 agrees to collect the second half of the payment after birth and an acceptable litter is confirmed.

T3 Retrievers will provide documentation of STUD Dog: OFA Certifications, AKC Certification, Pedigree, and more.

T3 Retrievers will APPROVE AKC Registration for litter.

Brucellosis Screening will be checked by a veterinarian for DAM and SIRE prior to breeding.

T3 Retrievers will do three successful ties for live breeding. Each tie will be planned, monitored and proper assistance will be given when needed by Tiffany Hegglnnd.

AI will be an option if live breeding is unsuccessful-this will be performed through a veterinary clinic. The owner of Dam will be responsible for payment to the Vet Clinic.

The Buyer Agrees:

· To provide caring and loving homes for the litter. New owner(s) will be able to care for ALL the puppies' needs during their first eight weeks of life. When finding new homes, the Buyer will screen the new puppy owner to ensure the canine is placed into proper homes for example:

o The canines will be given adequate shelter in a warm and clean-living environment.

o The canines will not be neglected or mistreated in any manner.

o The canines will receive proper veterinary care

o The canines will receive good nutrition foods. Four to five star rated dog food is recommended. (rate dog food at www.dogfoodadvisor.com)

o The canines will receive regular exercise daily.

o The canines will not be rehomed before eight weeks of age.

ABSOLUTELY NO PUPPY MILLS ALLOWED!

· Dam has cleared ALL requested health clearances before breeding.

· The Buyer will provide up-to-date medical records of Dam.

· Dam will be treated well through the pregnancy and after: nutritious foods, supplements are recommended, no excessive exercising, etc.

· The owner(s) will assist the dam during labor to ensure the following:

o Dam is safe and healthy during delivery (any complications bring the Dam to the emergency veterinarian immediately.)

§ Dam will not be left alone to deliver the litter.

o The puppies are given the mother's colostrum as soon as he/she is born.

o Any complication to the puppy's health, then bring the puppy to the emergency veterinarian immediately.

o The puppies will receive the first set of vaccinations, deworming, and wellness checks with a licensed veterinarian at six weeks of age.

o Puppies are rehomed no sooner than seven weeks of age.

· The Buyer will keep T3 Retrievers informed on the progress of pregnancy including when the puppies are born and how many puppies in the litter.
